



Mumps Outbreaks - update and investigation advice

The mumps outbreaks we've reported previously continue – at the time of writing there had been over 35 cases confirmed in the Waikato (mostly around Hamilton) in 2017, with reports of mumps from most other districts in New Zealand.

Please note that the NZ Microbiology Network has recently published advice on appropriate laboratory testing, **a viral buccal swab for PCR is the recommended sample**, from the affected side (if unilateral), and ideally within three days of parotitis onset but up to seven days. Mumps serology is not routinely recommended for diagnostic purposes.

We remind you again to notify us **on suspicion**. In addition to this being a legal requirement, it gives us a chance to discuss symptoms, appropriate testing, potential source(s) and contacts, and to ensure suspect case has been given appropriate isolation advice. A significant number of cases in this outbreak have not been notified, and have only come to public health attention when people at the WDHB lab contact us to ask whether to process specimens received.

Updated Policy for the Authorisation of Yellow Fever Vaccinators and Vaccination Centres
The new policy will take effect Tuesday, 15 August 2017 for all new and renewing vaccinators and centres. Following consultation the main changes to the Policy involved:

- removing the requirement for doctors to be registered with a specific vocational scope
- enabling qualifying nurse practitioners and registered nurses working in travel health to be authorised as yellow fever vaccinators
- minor changes to clarify wording throughout the policy.
